LOAD SERVING ENTITY COMPLIANCE REQUIREMENT FORM

On an annuals basis, EGSs providing retail electric supply service (i.e. take title to electricity) must file with the Commission this Load Serving Entity (LSE) Compliance Requirement Form. EGSs are directed to attach to this form documentation which provides the following:

- Proof of registration as a PJM LSE, or
- Proof of a contractual arrangement with a registered PJM LSE that facilitates the retail electricity services of the EGS.

Examples of sufficient documentation to satisfy this compliance requirement include, but may not be limited to:

- A screen print showing that the EGS is listed as a Party to an effective version of the PJM Reliability Assurance Agreement (RAA), located at Schedule 17 of the RAA.
- Correspondence, such as an e-mail screen print or regular mail scan, from PJM verifying membership as an LSE.
- Documentation of an effective contract between the EGS and another party that serves as the LSE on behalf of the EGS. In such a case, the documentation must also include proof that the party fulfilling the LSE role is indeed registered with the PJM as an LSE

EGSs may mark all or portions of their filing confidential.

EGSs which do not provide retail electric supply service, such as brokers, must file an LSE Compliance Requirement Form with the appropriate box checked below. No attached documentation is necessary for EGSs whom operate in such a capacity.

PJM has completed accounting settlements for February, 2016 under the PJM Open Access Transmission Tariff and the Operating Agreement of PJM Interconnection LLC.

The official PDF version of the billing statement, as well as CSV and XML versions, can be found in the "Billing (Monthly)" Report Category within MSRS. Also, the "Monthly Billing Statement Recipients" list can be accessed under this "Billing (Monthly)" Report Category. MSRS can be accessed via the PJM eSuite home page.

Please continue to maintain a single point of contact at your organization regarding PJM billing matters. Changes to your contact information may be performed by submitting a Billing Change Form (available at http://www.pjm.com/markets-and-operations/billing-settlements-and-credit/form-billing-contact-change.aspx).

Payments/Disbursements - Note Dates and Times

Payment should be made to PJM prior to 12:00 PM Eastern Prevailing Time (EPT) on March 11, 2016 using the bank instructions listed on your invoice. Payment to all credited parties will be initiated by 05:00 PM EPT on March 14, 2016. Note: The March 1-2 weekly month-to-date (MTD) bills will also be due on March 11, 2016. PJM expects to receive one net payment for both the February, 2016 monthly and the

March 1-2 weekly MTD invoices for those organizations that have a total net payable to PJM and vice versa, PJM will initiate one payment on March 14, 2016 to those organizations that have a total net due from PJM related to the February 2016 monthly and the March 1-2 weekly MTD invoices. In addition, for those organizations that have completed an ACH Draft/Debit authorization form, and have a total net payable due to PJM, PJM will debit your bank account on March 11, 2016 for the total net charge related to both bills. To confirm payment totals or for any questions concerning electronic funds transfer or payment procedures contact PJM's Cash Management Department at cashmanagement@pjm.com or (866) 400-8980.

Special Note: Included in February's monthly bill are the following:

- Billing adjustments for various Reactive Revenue corrections and updates impacting Reactive Supply and Voltage Control charges and credits.
- Correction of Capacity shortfall MWs (RPM) for a specific member's resources, resulting in billing adjustments to Capacity Deficiency charges and credits.
- Refunds for unauthorized Black Start compensation paid to a specific unit for the period December 2002 April 2013 resulting in billing adjustments to Black Start charges and credits.
- Refunds resulting from a voluntary return of excess CT LOC credits from a member, resulting in billing adjustments to Balancing Operating Reserves charges and credits for the time period July 2010 to March 2013.

Note:

Each member has the right to disclose their PJM Settlement billing statements as they choose. However, the front page of your billing statements includes PJM Settlement banking information that is not intended to be publicly shared. In order to reduce the risk of hacking attempts or potential fraud against PJM Settlement's bank accounts, we ask that all bill recipients be mindful about keeping PJM Settlement banking information confidential.
