We represent Frontier Communications of Breezewood, LLC, Frontier Communications of Canton, LLC, Frontier Communications of Lakewood, LLC, Frontier Communications of Oswayo River, LLC, and Frontier Communications of Pennsylvania, LLC (collectively, the "Frontier Companies") in the above-referenced matter. On March 17, 2016, a Complaint was filed by the Office of Small Business Advocate ("OSBA"). The Frontier Companies received the Complaint on March 21, 2016, and an Answer is presently due by March 31, 2016.

By this letter, the Frontier Companies respectfully request **an extension of twenty days, or until April 20, 2016**, in which to file their Answer and any other responsive pleadings to the Complaint. The Frontier Companies are currently in the process of investigating matters raised in the Complaint and compiling information informally requested by the OSBA. It is our hope that the parties will be able to address the issues in the Complaint and reach an amicable resolution of those issues during this extension period.

I have discussed this matter with Steven C. Gray, Assistant Small Business Advocate, who has authorized me to state that the OSBA has no objection to the requested extension.
