

- NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3, and 4).
- NOTE 2 - Hourly rates (Columns 2, 3, and 4) are based on the day or days, or periods of days, as indicated during which services are performed.
- NOTE 3 - Hourly rates (Columns 2, 3 and 4) computed in quarter hour periods; fractions of one-quarter hour considered one-quarter hour.
- NOTE 4 - When a holiday falls on a weekday or Saturday, the rates named in Columns 1 and 3 shall be applicable.
- ▲NOTE 5 - Applicable travel charge will be determined based on the distance from terminal to either the origin or destination of shipment, whichever furthest:

MILES

0	10	One (1) hour
10	15	One and one half (1.5 hrs)
15	20	Two (2) hours
20	25	Two and one quarter (2.25 hrs)
25	30	Two and one half (2.5 hrs)

- NOTE 6- Minimum transportation charges: Sundays and Holidays: six (6) hours at rates named in Column 3 plus applicable travel charge. Weekdays: three (3) hours at rates named in Column 2 plus applicable travel charge. Saturdays: four (4) hours at rates in Column 4 plus applicable travel charge.
- NOTE 7 - Waiver of minimum charges - carrier convenience: Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filed. And said move is performed solely at the carriers convenience. In such instances the carrier shall charge based on the actual time to complete move plus applicable travel charge.
- NOTE 8 - Where service commences at the request of the shipper after 5:00PM and before 6:00AM, rates shall be shown in Column 4.
- NOTE 9 - When a piano is included in the shipment the following charges will apply in addition to the applicable hourly rates contained herein.
