
The proposed hourly rates are being increased for shipments of household goods, in use forty (40) miles and less.

NOTE 1 - MINIMUM TRANSPORTATION CHARGES: Sundays and Holidays: 8 hours at rates named in Columns 1 and 2. Other than Sundays and Holidays 6:01 PM to 6:00 AM: 4 hours at rates named in Columns 1 and 4.

NOTE 2 - When a Holiday falls on a Saturday, rates named in Columns 1 and 2 shall be applicable.

NOTE 3 - Rates named in Columns 3 and 4 apply from 6:00 AM to 12 Midnight on any day when a higher rate is shown for the following day.

NOTE AA - When distance from original point of origin to final destination is more than 15 miles (to 40 miles inclusive) apply 1 hour travel charge. When distance from original point of origin to final destination is 15 miles or less, apply one-half hour travel charge.
