REVISED BRIEFING ORDER

A hearing was held in this matter on Thursday, June 29, 2006, and A Briefing Order was issued on June 30, 2006. The Briefing Order indicated that Main Briefs were due on August 10, 2006, and that Reply Briefs were due on August 24, 2006. This briefing schedule was premised upon the assumption that the transcript for the June 29, 2006, hearing would be received within 21 days, or by July 20, 2006. However, the transcript was not available until July 31, 2006, which was 32 days after the hearing.

On July 31, 2006, I received a request from Frank G. Procyk, Esquire, on behalf of Whitehall Township, requesting a briefing extension to account for the eleven-day delay in receiving the transcript. Mr. Procyk suggested that Main Briefs be due on August 21, 2006, and that Reply Briefs be due on September 6, 2006, to account for the intervening Labor Day holiday. As of today, August 1, 2006, no party has objected to this request, and as I find that good cause exists for the extension, it will be granted.

THEREFORE,

IT IS ORDERED:

1. That the revised briefing schedule proposed by Whitehall Township on July 31, 2006, is hereby adopted.

2. That Main Briefs are due on August 21, 2006, and Reply Briefs are due on September 6, 2006, under the terms and conditions previously set forth in prior Orders herein, dated March 14, 2006, and June 30, 2006.
