

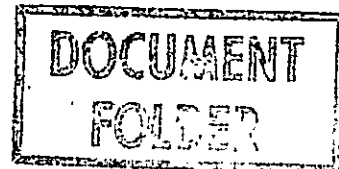



Dear Motor Carrier:





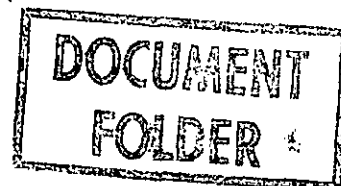
