- C. Pursuant to settlement of its most recent base rate case, Penelec calculates its proposed DSIC rate using the 9.90% equity return rate set forth in the Commission's Bureau of Technical Utility Services Report on the Quarterly Earnings of Jurisdictional Utilities, released on January 28, 2016.
- D. Penelec proposes to apply the DSIC equally to all customer classes except customers served on Rate Schedules GP and LP at voltage levels over 46,000 volts.
- E. Penelec provides electric service to approximately 584,000 residential, commercial and industrial customers in all or portions of thirty-one counties in Pennsylvania.
- F. The proposed DSIC rate of 0.043% may be unjust or unreasonable, in violation of Sections 1301, 1351, 1353, 1357, and 1358 of the Public Utility Code, 66 Pa. C.S. §§ 1301, 1351, 1353, 1357, 1358.
- G. The Consumer Advocate is empowered to represent the interests of consumers before the Pennsylvania Public Utility Commission, pursuant to Act 161 of the Pennsylvania General Assembly, 71 P. S. §§ 309-1 *et seq*, as enacted July 9, 1976.
- H. After initial review of Penelec's filing, the Consumer Advocate files this Formal Complaint in order to ensure that the Company's proposed DSIC tariff and DSIC rate do not result in rates and charges that are excessive, discriminatory or otherwise contrary to statute, Commission regulations or policy.

## 5. RELIEF

The Consumer Advocate respectfully respects that the Public Utility Commission:

- A. Hold evidentiary hearings as provided by Section 1355 of the Public Utility Code, 66 Pa. C.S. § 1355, to review the Petition;
- B. Hold public input hearings in Penelec's service territory, if consumer interest arises, 66 Pa. C.S. § 1355;

- C. Modify or reject the DSIC and initial tariff if they are not found to be in compliance with Sections 1351, 1353, 1357 and 1358 of the Public Utility Code, 66 Pa.C.S. §§ 1351, 1353, 1357, 1358;
- D. Modify or reject the DSIC and initial tariff if they are not found to be just and reasonable and in the public interest; and
  - E. Grant any other relief deemed necessary.

# PUBLIC STATEMENT OF THE OFFICE OF CONSUMER ADVOCATE PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving the initial Distribution System Improvement Charge (DSIC) tariff and rate proposed by Pennsylvania Electric Company (Penelec or the Company) at Docket No. P-2015-2508936.

On February 16, 2016, Penelec filed a Petition for Approval of a DSIC and a proposed DSIC tariff, pursuant to 66 Pa. C.S. § 1353. The Company estimates a DSIC rate of 0.043%. The Acting Consumer Advocate has filed this Intervention with the Commission to ensure that each aspect of Penelec's proposed tariff is scrutinized and that the proposed DSIC rate is consistent with Sections 1301, 1351, 1353, 1357 and 1358 of the Public Utility Code, 66 Pa.C.S. §§ 1301, 1351, 1353, 1357, 1358, and sound public policy. A thorough analysis and review are appropriate because the proposed tariff will implement new legislation. It is important that the DSIC be calculated correctly, recover only costs of DSIC-eligible property, and be applied equally to all customer classes, consistent with Act 11 and prior Commission Orders. The OCA, therefore, will seek to ensure that any DSIC rate approved by the Commission is not unduly discriminatory or otherwise excessive.
