
THEREFORE, as per PUC code, I further plead with this honorable court that this matter now be brought to hearing.



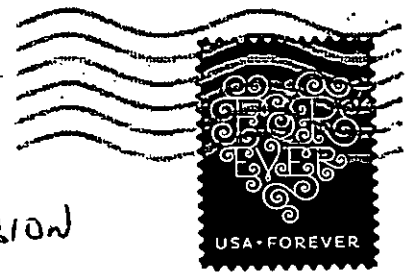

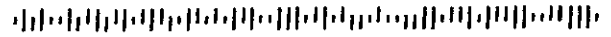
