In connection with AGR Group Nevada, LLC's (the "Company") Natural Gas Supplier License No. A-2014-2400854, please find the following update to the information found on the Application with respect to ownership of the Company.

At the time of the Application, the ownership structure of the Company was comprised of three entities: FMR Management, Inc. QLIV Consulting, Inc. and HNH, Inc. (the "Former Owners"). The individual owners of the Former Owners remain the same. The Former Owners formed a new entity; AGPB Holdings, LLC, a Delaware limited liability company ("AGPB"), and on November 4, 2015 contributed all of their collective ownership in the Company to AGPB pursuant to the applicable operating agreement. AGPB is a holding company with no business operations outside the ownership of the Company.

AGPB then formed a new entity in the name of Quantum Energy Holdings, LLC ("Quantum"), a Delaware limited liability company, as part of a joint venture with GPB Energy Holdings, LLC ("GPB"), a Delaware limited liability company. Pursuant to the applicable operating agreement, AGPB contributed 100% of its ownership of the Company to Quantum for a 50% ownership position of Quantum. GPB made a cash contribution to Quantum for a 50% ownership position of Quantum.

Therefore, the new and current owner of the Company is Quantum, which is jointly owned in equal parts by AGPB and GPB. While GPB is represented on the Board of Directors of Quantum, it is not otherwise involved with any of the day-to-day operations of the Company. The Former Owners will continue to oversee the Company's operations.
