
This process takes the action out of my hands and forces me to rely on others to file.

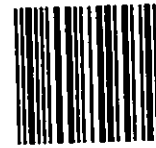

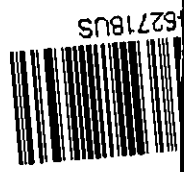
