Dear Secretary Chiavetta:

X5 OpCo LLC hereby clarifies for the record in the above-referenced matters, a statement originally made in the *Joint Application of X5 OpCo LLC and CornerStone Telephone Company, LLC, A-2015-2521384, A-2015-2521463* ("Joint Application") regarding CornerStone Telephone Company, LLC's ("CornerStone") provision of service to residential subscribers. As addressed herein, CornerStone has never provided service to residential subscribers in the Commonwealth.

On December 30, 2015, Pennsylvania regulatory counsel for X5 OpCo LLC and Cornerstone submitted the Joint Application to the Commission. Footnote 1 to the Joint Application appearing on Page 3, states, "CornerStone provides residential service to its employees, and to several multi-dwelling units that bundle CornerStone's service into their rental packages." This statement was intended as part of a general CornerStone description, and not specifically applicable to Pennsylvania. Upon inquiry by staff, CornerStone has since confirmed that it does not now, nor has it ever, provided residential telecommunications services in the Commonwealth. The statement applied exclusively to the Company's New York operations. A separate statement from CornerStone's Chief Financial Officer confirming this fact is attached.
