



This is to inform you that the Initial Hearing on the above-captioned case now scheduled to be held on Monday, June 4, 2001 at 10:00 a.m. in Pittsburgh, Pennsylvania has been canceled.

The Pennsylvania Public Utility Commission, by Order entered March 23, 2001, adopted a new policy, which revised the evidentiary criteria used to review limousine applications. Essentially, this Commission Policy eliminated the requirement for an applicant to establish need for limousine service. The Commission has adopted new procedures that apply to existing applications currently assigned to the Office of Administrative Law Judge for hearing and to new applicants. The hearing in this case is being canceled and the case referred to the Commission's Bureau of Transportation and Safety to be processed under these new procedures. 




