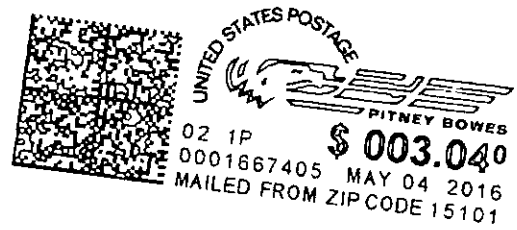
5 THE COURT: Good morning. This is the
