I found a company, had motor shipped out and payed thousand of dollars to be fixed. Truck was towed to shop May 12, 2015

I took my insurance off while in shop cause I was told motor should be shipped back in about a month.

Came to having problems with the company and found out they are scam artist. The f.B.I is on them also. finally after year or more the motor has been returned. Still was not built correctly. Still fighting for correct parts. It has now been partial resolved. The motor is being put back in the truck now. Still no promise it will run right.

I had got intouch with Harrisburg in early 2015. Told them of my truck. So we put my registration on hold and they sent me reinstatement papers for when I need my registration back.

I also recieved my yearly P.U.C Annual estimate gross money for year. Which in return I called them told them I havent worked my truck. So they told me to put in "0" and send it in. Which I did.

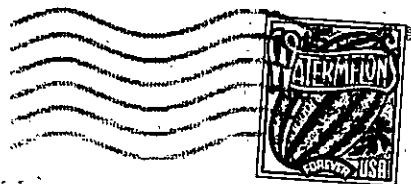
