<u>Mambo Movers, Inc.</u> (Petitioner) respectfully encloses herewith an original and three (3) copies of a Petition for Reinstatement of common carrier Certificate No. A-00115371 based on the facts contained herein.

Enclosed and marked <u>Exhibit 1</u> is an Order of the Pennsylvania Public Utility Commission which was adopted January 12, 2006 and entered January 25, 2006 cancelling Respondents operating authority under Docket No. A-00115371.

The reason initially for the Complaint was failure to maintain evidence of cargo insurance on file with this Commission, a violation of the Public Utility Code at 66 Pa. C.S. 512, 51 Pa. Code 32.2(c) and 52 Pa. Code 32.11(a), 32.12(a) or 32.13(a).

Respondment researched from Commission's Public Record a history of its complaints. Including this Complaint a total of three (3) have been recorded. All three (3) complaints specifically pertain to failure to maintain evidence of cargo insurance. The first complaint C0301 opened 7-25-03 and closed 8-16-03. The second complaint C0401 opened 10-4-04, however due to an administrative oversight at the Commission the close date was not recorded.

There is no record of any consumer complaint filed against Respondent.

Also enclosed and marked <u>Exhibit 2</u> is a letter addressed to Mr. Ken Sataloff, President of Sataloff Transportation Consultants, Inc. Mr. Sataloff is our Transportation Consultant and received the enclosed exhibit from Mr. Tim Karczewski of Caputo Insurance Agency.

Mr. Karczewski is the current insurance agent for Respondent.

Please note that Respondent did notify its agent that the Commission had not received the cargo insurance filings for the 2004/05 coverage period. Two (2) separate cargo insurance filings were made for Respondent, but in both instances the Commission has indicated not receiving either one of the filings.

Respondent as well has remitted to the Commission a \$100.00 fine.

Respondent continually makes every effort to annually meet the tariff, insurance and assessment compliance with the Pennsylvania Public Utility Commission in order to protect its operating authority.

Respondent depends on its Pennsylvania operating authority as well as its interstate operating authority transporting household goods in use to provide service to the general public. The revocation of its Pennsylvania operating authority will result in a fatal financial condition.

Respondent is also aware everyday of non-certificated companies taking away moving business from them in the Philadelphia, PA market.

Your Respondent respectfully prays that the Pennsylvania Public Utility Commission will reinstate Certificate No.A-00115371 in an expeditious manner so that it can again provide professional moving service to the residents of Pennsylvania.



Please find enclosed a copy of the Form H that was issued by Century Surety Company to the PA PUC for policy year 6/24/04-05. The certificate was sent on August 20, 2004 directly to the PA PUC. We have requested the Form H for the 6/24/05-06 policy through Travelers Insurance Company (upon receipt, it will be faxed to your office).

Once the insurance carrier advises our office that the Form H has been completed and sent there is no further follow up from our office. Normal procedure would be, if the PUC claims they did not receive the Form H, we would then contact the insurance carrier to have the form issued again. In this instance, the Insured did advise us on August 13 2004 that the PUC did not receive the Form H, we advised the insurance carrier and had the Form H issued again, and a copy for verification was faxed to our office.. (copy attached)

We recently became aware of a problem with the PUC when his Mambo Movers Auto policy renewed. We called the PUC and was advised that the problem was with the Cargo filing not the auto filing. The PUC claim that they never received the Form H for the 06/24/04-05 policy period. We advised the insured to pay the fine and proceed to get their PUC authority reinstated. Once this is done, we will follow up for both the auto and cargo insurance carriers to refile the Form E and H. Please advise our office when their reinstate is completed.

Dear Secretary McNulty:

On May 2, 2006 I filed with your Commission a Petition for Reinstatement of our common carrier authority under Certificate No. A-00115371.

On May 18, 2006, under your signature, I received a notice returning our Petition for Reinstatement on the basis of an untimely filing, and indicating we must file a new application for authority.

Mambo Movers, Inc. provides common carrier service to the general public in the Philadelphia, PA area transporting household goods in use. We purchased this authority from James Stewart on or about April 2001.

Since that time we have complied with all tariff, assessment and insurance requirements except for brief periods of time with respect to cargo filings.

During the entire period that we have held this operating authority we have received <u>no consumer complaints</u>.

We provide excellent service to the Pennsylvania residents often handling valuable personal effects which require great attention in view of their age, value and irreplaceable possibilities.

We are Petitioning your Commission under the provisions of Pa. Code, Title 52, Sub Section 1.91 "Application for Waiver of Formal Requirements".

FOLDER 1440 Lombard Street • Philadelphia, PA 19146 • phone: 215, 670, 9535 • fax: 215, 670, 9534 www.mambomovers.com The non-compliance by your records of our cargo coverage, and certainly an inadvertent mistake on our part not responding to the Order from Public Meeting held on January 12, 2006, has caused us to lose the most important asset in providing transportation of household goods in use within the scope of our previously active authority. It is the only type of work we know in order to make a living. The permanent loss of this authority will cause us to close our business that we have worked so strenuously to succeed, and all because we made an inadvertent mistake in not timely responding to your Order. Everyone should be entitled to make a mistake and not pay such a terrible price.

We expect our insurance agent and the insurance carrier itself to provide your Commission with timely filed Certificates of Insurance. We certainly pay our premiums in a timely manner or be cancelled.

You will note from the enclosed Petition for Reinstatement of Authority that our insurance carrier filed twice the Certificate of Cargo coverage, but for some unknown reason your Commission indicates no receipt of this filing. It is not from a lack of effort that cargo insurance coverage was not met.

One of our attachments to the Petition for Reinstatement of Authority is a letter from Mr. Tim Karczewski clearly indicating that our company did advise him on August 13, 2004 that the Pa. P.U.C. did not receive Form H, and that Mr. Karczewski advised the insurance carrier to file another Form H again.

Secretary McNulty, we respectfully request that consideration be given to reinstate our critically needed household goods in use operating authority in an expeditious manner so that we have some chance of surviving this horrific situation, and not losing everything we have worked so hard to build.

There are non-certificated companies providing household goods in use service everyday in spite of the efforts of the Pa. P.U.C. Please do not further penalize the legitimate moving company from providing excellent service to the residents within the Philadelphia area.






