Dear Raymond T. Carey:

This is in response to your inquiry in which you requested a change in name from Raymond T. Carey to RT Carey Trucking, LLC.

In order to make the requested changes, you must comply with provisions of Title 52 § 3.381(a)(6)(ii), which requires that you submit a verified letter of notification to the Secretary containing the following information:

- (I) The docket number of the motor carrier and the name of the motor carrier as presently shown in Commission's records.
- (II) A copy of the articles of incorporation or partnership agreement, if applicable, or other proper evidence of the name change.
- (III) The names of the owners of the stock and the distribution of shares, if applicable.
- (IV) The names of the officers and directors of the corporation, if applicable.
- (V) A statement that there has been no change in the ownership or control of the business.
- (VI) A copy of the fictitious name registration form filed with the Department of State, under Title 54 Pa.C.S.

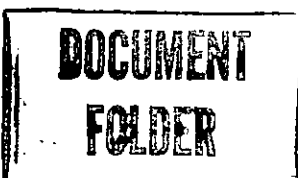
In accordance with Title 52 § 3.381(a)(7)(ii)(B), upon submission of the above items, the Commission will endorse the existing certificate or permit of the motor carrier in the name of the new entity, with no change to the existing docket number. Within sixty (60) days of the Commission's endorsement, the motor carrier shall effect the change in entity on its insurance filings (Form E and Form H or cargo waiver if applicable) and tariff filing, if applicable, with the Commission.


