Jones, as set forth during the on-the-record discussion that took place on June 16, 2016, which summarized the terms of the settlement that was achieved between the parties.

Respondent has agreed to pay all outstanding assessment amounts that are due as of this date and an agreed-upon civil penalty in the amount of \$5,073 regarding the instant Complaint. Given that Respondent has agreed to the terms of the payment schedule in order to avoid litigating this matter, the Complaint should be deemed satisfied and the matter marked closed.

Pursuant to Section 5.24(a) of the Commission's regulations, 52 Pa. Code § 5.24(a), the Bureau of Investigation and Enforcement (I&E) of the Pennsylvania Public Utility Commission (Commission) and Celebrity Limousine Service Inc. (Respondent) submit this Certificate of Satisfaction to certify that the above-captioned Formal Complaint filed by I&E against Respondent and docketed by the Commission at Docket No. C-2015-2498921 has been satisfied.

Respondent has agreed to submit to the Commission a total of \$40,653 on or before August 1, 2016, which will be applied in the following manner: \$35,580 to satisfy the remainder of Respondent's outstanding assessment for the July 1, 2014 to June 30, 2015 Fiscal Year (2014-2015 Fiscal Year) and \$5,073 as the agreed-upon civil penalty for Respondent's failure to timely pay its 2014-2015 Fiscal Year Assessment. Should Respondent fail to comply with the aforementioned terms, I&E will immediately notify the Commission's Office of Administrative Law Judge to request the scheduling of a hearing regarding the above-captioned Formal Complaint.

Respondent has also agreed to submit to the Commission \$27,803 on or before December 31, 2016 to satisfy Respondent's outstanding assessment for the July 1, 2015 to June 30, 2016 Fiscal Year (2015-2016 Fiscal Year) and I&E has agreed to hold in abeyance the filing of any complaint related to the 2015-2016 Fiscal Year Assessment if such payment is made on or before December 31, 2016. Should Respondent fail to comply with the aforementioned terms, I&E reserves the right to institute a Formal Complaint seeking relief, as deemed appropriate.

The above-captioned Formal Complaint should be deemed satisfied and the Commission's files closed.
