EXCEPTIONS:

I, the Plaintiff, did on March 29, 2016, withdraw his complaint against PECO Energy with correspondence to the Administrative Judge's office and to Ms. Lee at PECO.

In withdrawing this complaint, I requested mediation in this matter and have not received any response to that request.

The defendant, in denying the plaintiff a payment arrangement, does not take into account the changed personal and financial circumstances existing NOW, choosing instead to make a determination on situations existing years ago.

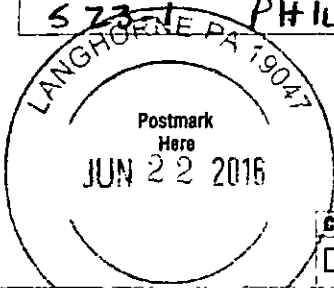

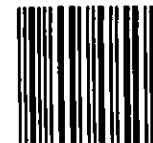
