MOTION TO STRIKE COMPLAINANT'S REPLY TO RESPONDENT'S ANSWER TO AMENDED FORMAL COMPLAINT

AND NOW COMES Respondent, Maroadi Transfer & Storage, Inc., by its attorney, John A. Pillar, and presents the following motion to strike the Complainant's reply to the Respondent's Answer to the Amended Formal Complaint, and in support thereof states as follows.

1. On or about May 25, 2016, Respondent filed an Answer to the Amended Formal Complaint in the above docketed proceeding and New Matter.

2. Complainant has filed a pleading entitled "Complainant's Answer to Respondent's "New Matter" & Reply to Respondent's Answer to Amended Formal Complaint". Paragraphs 1 through 40 of the Complainant's Answer are directed to the Respondent's Answer to the Amended Formal Complaint.
