Please accept this notification of Joint Complainants of compliance with paragraph 26 of the Joint Petition for Approval of Settlement, page 30 of the Initial Decision dated August 21, 2015, and the final Order dated December 3, 2015 in the above-captioned proceeding. The Commonwealth of Pennsylvania, Office of Attorney General, through the Bureau of Consumer Protection and the Acting Consumer Advocate, Tanya J. McCloskey provided the Report of the Administrator of the Refund Pool to HIKO Energy, LLC, the Pennsylvania Public Utility Commission's Bureau of Consumer Services, and Administrative Law Judges Elizabeth Barnes and Joel Cheskis in the format and medium requested by each.

Specifically, as of June 29, 2016, 8,070 checks were issued representing checks to all eligible customers. Of those checks issued, 5,051 refund checks totaling \$1,223,926.02 were cashed and paid; 906 refund checks totaling \$273,849.29 were returned undeliverable; and 2,113 refund checks totaling \$527,608.32 were delivered and still uncashed.
