In compliance with the requirements of 15 Pa.C.S. Section 1306 (relating to Articles of Incorporation), the undersigned, desiring to be incorporated as a business corporation, hereby certifies (certify) that:

1. The name of the corporation is:

A. MASTROCCO, JR. MOVING & STORAGE, INC.

2. The location and post office address of the initial registered office of the corporation in this Commonwealth is:

- 3. The corporation is formed under the provisions of the 1988 Pennsylvania Business Corporation Law.
