

In compliance with the requirements of 15 Pa.C.S. Section 1306 (relating to Articles of Incorporation), the undersigned, desiring to be incorporated as a business corporation, hereby certifies (certify) that:

1. The name of the corporation is:

A. MASTROCCO, JR. MOVING & STORAGE, INC.

2. The location and post office address of the initial registered office of the corporation in this Commonwealth is:

320 Constance Drive, Warminster, PA 18974

3. The corporation is formed under the provisions of the 1988 Pennsylvania Business Corporation Law.

4. These Articles of Incorporation may be amended in the manner prescribed at the time by statute, and all rights conferred upon shareholders herein are granted subject to this reservation.

5. The aggregate number of shares which the corporation shall have authority to issue is: 500 shares of common stock.

6. Subject only to the limitations in Section 1713(b) of the Pennsylvania Business Corporation Law of 1988, as amended, a director of the corporation shall not be personally liable, as such, for monetary damages for any action taken or failure to take any action unless:

- b) the breach or failure to perform constitutes self-dealing, willful misconduct or recklessness.
