VERIFIED STATEMENT OF MARTIN L. ANDERSON and JERRY G. McLAINE
ON BEHALF OF J. M. LEASING CO.

The Undersigned, whose names are Martin L. Anderson and Jerry G. McLaine, have a business address of 295 Grand Avenue, Clarion, PA 16214. The Undersigned were granted a Certificate of Public Convenience by the Pennsylvania Public Utility Commission ("Commission") in 1999 at Docket No. A-00116351 under the partnership's name, which is Martin L. Anderson and Jerry G. McLaine d/b/a J.M. Leasing Co. ("Partnership"). The Undersigned have decided to incorporate the Partnership under the name of J. M. Leasing Co. Pursuant to 52 Pa. Code §3.381(a)(7)(ii), the Undersigned are submitting this Verified Statement to the Commission and requesting that the Certificate of Public Convenience issued to Martin L. Anderson and Jerry G. McLaine doing business as J.M. Leasing Co. be changed to indicate that the operating rights are held by and issued to the successor corporation, which has a business name of J. M. Leasing Co.

The following information is being submitted to comply with the Commission's regulations to support this change in entity of a motor carrier, which change is not accompanied by a change in the ownership or control of the business:

1. The name of the motor carrier as presently shown in the Commission's records is Martin L. Anderson and Jerry G. McLaine d/b/a J.M. Leasing Co. and its Docket No. is A-00116351.

2. Attached as Exhibit "A" is a copy of the date-stamped Articles of Incorporation, which indicate that, on February 22, 2008, the Pennsylvania Corporation Bureau approved the formation of the Corporation known as J. M. Leasing Co.

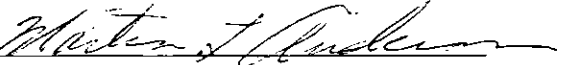
