Re: Cancellation of Pennsylvania Electric Generation Supplier License, A-2010-2201370

MidAmerican Energy Company served retail electric customers in Pennsylvania as an Electric Generation Supplier ("EGS") from 2011 until December 31, 2015, under Pennsylvania Public Utility Commission ("PA PUC") license number A-2010-2201370. During 2015, MidAmerican Energy Company transferred its unregulated retail services division to MidAmerican Energy Services, LLC, a Berkshire Hathaway Energy affiliate and EGS with authority under PA PUC license number A-2015-2496354.

Effective January 1, 2016, all MidAmerican Energy Company customers were transferred to MidAmerican Energy Services, LLC. MidAmerican Energy Company is no longer serving any customers in Pennsylvania and requests cancellation of its PA PUC license number A-2010-2201370. MidAmerican Energy Company also requests the subsequent release of its license bond on file with PA PUC. The bond may be sent to my attention at the address listed above.

MidAmerican Energy Company intends to fulfill any remaining obligations, such as required reporting or assessment payments, but no longer intends to market or otherwise serve customers in Pennsylvania.

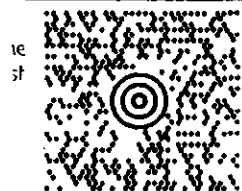

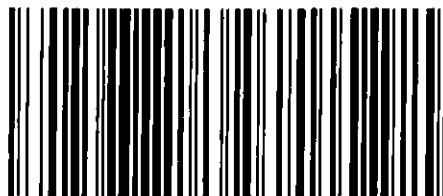
