The Commission is in receipt of the Objection you have filed to the Commission's General Assessment Invoice for FY 2007-2008. In that Objection, you have stated that your firm, Walmart Transportation LLC, has registered under the Unified Carrier Registration Program for the year 2007 and should not have been assessed pursuant to Section 510 of the Public Utility Code, 66 Pa. C.S. Section 510. After a review of your status as a UCR program participant, it is clear that you are UCR registered and, therefore, your assessment invoice for FY 2007-2008 is reduced to zero.

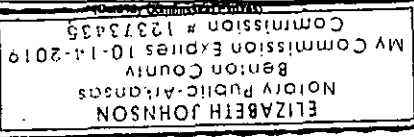
