- ASTRAL ENERGY LLC ("ASTRAL ENERGY") is licensed by the Pennsylvania Public Utility Commission to offer and supply Natural Gas services in Pennsylvania. Our PUC license number is <u>A-</u> <u>XXXX-XXXXXXX</u>.
- ASTRAL ENERGY sets the supply prices and charges that you pay. The Public Utility Commission
 regulates distribution prices and services. The Federal Energy Regulatory Commission regulates
 interstate pipeline prices and services.
- You will receive a single bill from your Local Natural Gas Distribution Company ("NGDC") that will
 contain their charges and ASTRAL ENERGY LLC's charges.
- Right of Rescission You may cancel this agreement at any time before midnight of the third business day after receiving this disclosure. You can contact us by phone, in writing or electronically (if available) to cancel this agreement. See Section 8 for how to contact us.

DEFINITIONS

- Supply Charge: Charge for the supply of Natural Gas
- Interstate Pipeline Charges: Charges for moving natural gas to the distribution lines of a distribution company

TERMS OF SERVICE

1. Variable Rate Plan Basic Charge

Customer will pay a variable price that can change every month. The variable price is a competitive market driven cost including transmission charges, capacity, congestion, line loss, or any other unforeseen cost billed by pipelines, as well as estimated total State taxes, and the gross receipts Tax, but excludes applicable state and local sales tax. There are no limits on how much the price may change from one billing cycle to the next. It is based on market conditions which may be influenced by unforeseen costs. There is no cancellation fee.
