I am writing on behalf of Joel Sicherman, owner of **BestDarnMovers**, 210 Division Street, Kingston PA 18704.



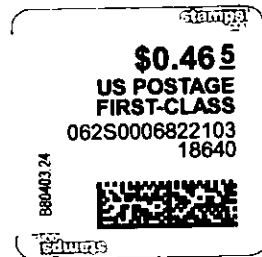
