On March 10, 2010, Nania Energy, Inc. filed an Application for a license to supply electricity or electric generation services in Maryland under COMAR 20.51. Additional information was filed on May 27, 2010 and June 21, 2010. The Company proposes to provide electricity broker services in Maryland for commercial and industrial customers without restrictions on the number and size of end use customers as described in the application.

After considering this matter at the June 30, 2010 Administrative Meeting, the Commission granted Nania Energy, Inc. a license to supply electricity or electric generation services in Maryland in accordance with its Application (License Reference Number IR-1857). The license granted by the Commission under this Letter Order is limited solely to electricity broker services to commercial and industrial customers.

Finally, Nania Energy, Inc. is reminded that it is under a continuing obligation to notify the Commission of any substantial changes to the information upon which the Commission relied in granting this license. A copy of the supplemental or updated information is required to be filed concurrently with the Office of People's Counsel.

ORDER

By the Commission:

I. INTRODUCTION

On March 5, 2012, Nania Energy, Inc. ("Applicant") filed a verified application with the Illinois Commerce Commission ("Commission") requesting a certificate of service authority to operate as an agent, broker, or consultant ("ABC") in Illinois pursuant to Section 16-115C of the Public Utilities Act ("Act"), 220 ILCS 5/1-101 et seq., and 83 III. Adm. Code 454, "Licensure of Retail Electric Agents, Brokers and Consultants" ("Part 454"). Applicant requests authority to offer services as an ABC for the procurement or sale of retail electricity supply for third parties in the State of Illinois. The Administrative Law Judge requested additional information and clarification of certain matters contained in the application. Applicant filed a verified response on March 16, 2012.

II. REQUIREMENTS FOR ALL APPLICANTS UNDER SECTION 16-115C OF THE ACT

Applicant is a business organized under the laws of Illinois and licensed to transact business in Illinois. Applicant has certified that it will comply with all applicable regulations; that it will comply with informational and reporting requirements established by Commission rule; that it will comply with informational and reporting requirements pursuant to Section 16-115C of the Act; and that it will comply with all other applicable laws, regulations, terms, and conditions required to the extent they have application to the services being offered by an ABC. Applicant has agreed to ensure that any person who acts on its behalf will comply with all applicable sections of Part 454. Applicant agrees that it will remain in compliance with the provisions of the Act and Part 454, and will ensure that authorizations received from customers, and all other applicable records are retained for a period of not less than three calendar years after the calendar year in which they were created. Applicant has agreed to adopt and follow rules and procedures to preserve the confidentiality of its customers' data. Applicant states that it has an active license to engage in the retail sale of electricity or natural gas in

Maryland. Applicant reports that there have been no complaints filed against it. Applicant indicates that it also operates under the assumed name of EverBright Energy.

III. FINANCIAL, TECHNICAL, AND MANAGERIAL REQUIREMENTS OF SECTION 16-115C

Applicant is required by Section 454.60 to demonstrate that it meets the managerial qualifications necessary to provide services as an ABC. Applicant must further provide an organizational chart that indicates the position of persons which satisfy the managerial qualification. Applicant has demonstrated that it meets the managerial qualifications set forth in Section 454.60. Attachment B to the application and the revised Attachment B submitted in response to the Administrative Law Judge ruling contain a corporate organizational chart and identify the occupational background information of the person being used to meet the requirements of Section 454.60(a).

Applicant is required by Section 454.70 to demonstrate that it meets the technical qualifications necessary to provide services as an ABC. Applicant has demonstrated that it meets the technical qualifications set forth in Section 454.70 with the information provided, including the information included in Attachment C. Attachment C contains occupational background information on the person being used to meet the requirements of Section 454.70(a).

Pursuant to the requirements of Section 454.80 of Part 454, Applicant provided a surety bond in the amount of \$5,000 issued by a qualifying surety authorized to transact business in Illinois. Applicant further agrees to comply with the Code of Conduct for ABCs contained in Section 454.90.

IV. COMMISSION CONCLUSION AND CERTIFICATE OF SERVICE AUTHORITY

The Commission has reviewed the application and attachments along with the supplementary information provided by Applicant regarding the technical, managerial, and financial requirements and all other requirements of the Act and Part 454 and finds that the Applicant sufficiently demonstrates compliance with the requirements. The Commission concludes, therefore, that Applicant's request for a certificate of service authority to operate as an ABC in Illinois should be granted and should include the following authority:

CERTIFICATE OF SERVICE AUTHORITY

IT IS CERTIFIED that Nania Energy, Inc. is granted service authority to operate as an agent, broker, or consultant for the procurement or sale of retail electricity supply for third parties in the State of Illinois.

V. FINDINGS AND ORDERING PARAGRAPHS

The Commission, having reviewed the entire record, is of the opinion and finds that:

- Applicant, a business organized under the laws of Illinois, seeks a certificate of service authority to operate as an ABC under Section 16-115C of the Act;
- (2) the Commission has jurisdiction over the party hereto and the subject matter hereof;
- (3) the recitals of fact and conclusions reached in the prefatory portion of this Order are supported by the record and are hereby adopted as findings of fact;
- (4) Applicant has demonstrated that it possesses sufficient financial, managerial, and technical resources and abilities to provide services as an ABC for the procurement or sale of retail electricity supply to third parties in the State of Illinois;
- (5) Applicant has complied with Section 16-115C of the Act and Part 454; and
- (6) Applicant should be granted a certificate of service authority to operate as an ABC as specified in this Order.

IT IS THEREFORE ORDERED by the Illinois Commerce Commission that Nania Energy, Inc. is hereby granted a Certificate of Service Authority authorizing it to operate as an agent, broker, or consultant; said Certificate of Service Authority shall read as that set forth in Section IV of this Order.

IT IS FURTHER ORDERED that Nania Energy, Inc. shall comply with all applicable Commission rules and orders now and as hereafter amended.

IT IS FURTHER ORDERED that, subject to the provisions of Section 10-113 of the Public Utilities Act and 83 III. Adm. Code 200.880, this Order is final; it is not subject to the Administrative Review Law.

Summary: Responsible for overall C&I sales activities at Nania. Responsibilities include leading by example, consistently demonstrating leadership by pursuing and closing business, maintaining an existing book, keeping abreast of industry changes, supplier products and processes, developing relationships with key supplier contacts, and reaching into new markets. Another key component of the position is the continuous development of sales personnel so that their skills and industry knowledge become industry benchmarks for excellence enabling them to grow and develop their book of business. Coordination, monitoring, and mentoring of C&I sales team members activities to assist them in meeting their goals is also required.

Duties and Responsibilities of VP of C&I Sales: Responsible for training, developing and retaining staff within C&I sales team. Involvement in the development of annual company business plan and establishing individual goals for direct reports, and perform quarterly reviews of such goals for all sales team members as well as annual review. Providing recommendations relating to compensation changes/rewards for C&I sales team. Also, directs and coordinates the marketing efforts of the sales team working with the Nania Marketing Manager. Administration of human resource policy as appropriate.

- 1. Work with the Controller and CEO to establish the yearly annual net sales goal for C&I as well as the individual annual sales target for C&I compensation with management.


