Kimberly G. Krupka has not provided me with the proof she claimed she would provide. Previously she had informed you that there was indeed proof that the two PPL Electric accounts were opened in my name using my SS#. However, she is not cooperating and has not provided any proof to support her claim.

Therefore, I believe:

- 1) Accounts were not opened by using my name and social security number.
- 2) The proof I had previously forwarded to Ms. Krupka shows that I did not live at the address in the claim.
- 3) Ms. Krupka's own exhibit states:

"Patricia Shirer's ex-husband Anthony Shirer age 66 accrued unpaid balance of \$3,470.88 which he is responsible for. Account # 5046089164"
- 4) All of the previously mentioned debts are Anthony Shirer's (66), along with all of the listed: late payments, budget billing, return checks, address changes (60 Cedar Acres), both account #'s, bankruptcy declarations and repairs, P.O. Box #, medical certification, payment agreements, and income verification.
