

CERTIFICATE OF SATISFACTION

1. Complainant is Cheryl L. Perlberg.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. (a) After a full discussion of all issues, Complainant, Cheryl L. Perlberg, and Respondent, PPL Electric, agreed that Complainant's next bill is to be issued within one week. Complainant will make a \$185 payment on that bill. Thereafter, Complainant will pay her monthly budget bill plus \$65 per month toward arrearages until all arrearages are paid in full. Respondent explained, and Complainant indicated an understanding, that initially her budget bill will be \$120. While the budget bill is \$120, Complainants' required payment will be a total of \$185 (representing \$120 for the budget bill and \$65 towards the arrearages). However, the budget bill will be evaluated every three months to ensure that the budget bill is consistent with Complainant's actual usage. Therefore, the budget bill may fluctuate every three

months. In the event the budget bill changes, Complainant is required to pay her budget bill plus the \$65 per month towards arrearages.


(b) Complainant agrees to withdraw her Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.


