



Please accept this Letter Petition on behalf of Reliant Energy Northeast LLC dba NRG Home and NRG Business ("Reliant") to renew its required level of financial security at the reduced level of 5%. Reliant's current required level of financial security was initially approved by the Commission through its Secretarial Letter dated December 15, 2016. This request is made consistent with the directives of the Secretarial Letter issued on April 8, 2016 at Docket No. M-2013-2393141. Please find the following information in support:

- 1) Reliant's gross receipts in Pennsylvania for the four most-recent quarters attached hereto as Appendix A (CONFIDENTIAL); and
