

To Whom it may concern,

I am writing this letter in regards to the complaint my company, J & A Transline, LLC, received on August 18, 2016. I apologize for the delay in response to this matter, I was under the impression this was a mistake because my insurance company, Progressive, had informed me that they had filed all appropriate documents with the state and provided me with the e-filed forms that were sent on 7/16/2016 (these of which are attached). I had called the number provided on the complaint and spoke with Kathy today to make sure everything was received and in good standing and she had told me they had Form E on file but had never received Form H from the insurance company in July. I was not aware of this until now so I have called our insurance to see what had happened and to please send this document over as soon as possible. This was the first time with our PA-PUC authority and we were not aware we had to file separate documents on both the federal and state level. Our insurance was up for renewal on July 2, 2016 and our policy was paid for and renewed on June 30, 2016 so there was not a lapse in insurance at any time. I would like to respectfully request if the \$500 fine for this matter could be waived. I am very well aware of the process of updating our insurances on both the federal and state side now for future filings. I will also make it my responsibility to now make sure they have provided all documents to the state of PA in the future. I greatly apologize for any inconvenience this has caused with the state and in hopes we can come to an understanding with the fine requested. Please let me know if you have any questions.
