Kindly recall that this matter is scheduled for a Call of the Docket in-person hearing before Your Honor on Tuesday, August 30th at 1:30 p.m. In the Complainant's formal complaint, she states that PECO is threatening to terminate her service and requests a payment agreement. Please be advised that PECO has received notice that Ms. Wallace has filed for Chapter 7 bankruptcy.

I have enclosed docket activity on the Chapter 7 bankruptcy matter In Re: Bernice and Kevin Wallace, Eastern District of Pennsylvania, Docket No. 14-15312. Ms. Wallace filed for Chapter 7 bankruptcy in the Eastern District on June 30, 2014. PECO is listed as one of the creditors in the bankruptcy schedule. The docket demonstrates the latest activity on August 16, 2016, where Ms. Wallace filed a Motion to Dismiss the bankruptcy. To date, the bankruptcy judge has not ruled on Ms. Wallace's Motion.
