CERTIFICATE OF SATISFACTION

1. Complainant is Anthony M. Shirer, II.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. (a) Complainant, Anthony M. Shirer, II, and Respondent, PPL Electric, agree that PPL Electric will remove the amount of \$3,470.88 from Account number 50460-89164, and shall not attempt to collect the same from Complainant, Anthony M. Shirer. Respondent, PPL Electric, specifically reserves its rights to seek payment from individuals other than Anthony M. Shirer, II.

(b) Complainant's current overdue balance is \$1,589.52 (which does not include the current bill due September 22, 2016). Complainant agrees to pay his current bill, in the amount of \$183.05, by September 22, 2016, and thereafter will pay his current monthly bills plus \$117 per month towards arrearages until all arrearages are paid in full. So long as Complainant makes timely payments in accordance with this Agreement, Respondent will not

access late fees or penalties. However, failure to make timely complete payments may void the payment agreement, with the entire balance becoming due and owing.

(c) Complainant withdraws his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.
