- (1) Due to escalating insurance costs this past March when it was time to renew my policy I decided to change carriers. In error I neglected to notify Harrisburg of this change.
- (2) I received a letter May 2, 2016 from you that my operating authority was suspended due to non proof of Insurance on my part.
- (3) I immediately contacted my Brokers, Reed, Wertz & Roadman, Inc. and they forwarded proof of Insurance covered by Berkshire Hathaway ( Responsibility ID card enclosed.
- (4) On May 17th , 2016 I received a letter from you Lifting my suspension and acknowledging receipt of Insurance coverage. Permitting me to resume operations. I thought that this was the end of the problem.
- (5) On Saturday August 20, 2016 I received a notice that my operating authority was cancelled for failure to maintain evidence of cargo and liability insurance. Additionally the said letter informed me that I had ignored a certified letter dated May 21, 2016. No letter was received .
- (6) At no time was there any lapse of Insurance coverage including the transition from one company to another. I take these matters very seriously as my living is held in the balance.
- (7) I'm at a loss as to what to do to satisfy you. I called the phone given at the bottom of the letter and got a recording and left a message first thing this Monday morning. I have had no response at the time of writing this letter. I have responded timely to all letters received. Copies of all letters received attached.
- (8) As I have responded timely I trust that you will reinstate my operating Authority as soon as possible. Additionally that you would stop any further proceedings.

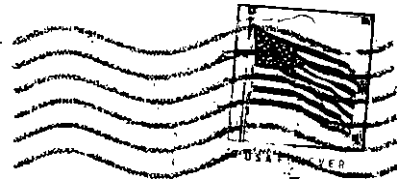
