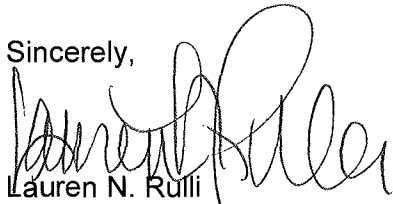

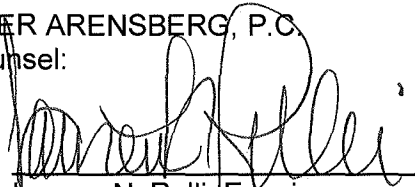
1. Respondent and Complainant discussed settlement of the complaint. The parties were able to reach a settlement.

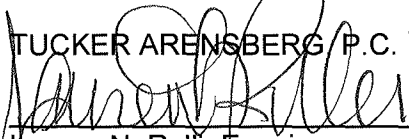
