On July 18, 2002, the Pennsylvania Public Utility Commission (“Commission”) issued an Order and License in Docket No. A-110156 authorizing ENGIE Resources Inc.’s predecessor to begin to offer, render, furnish or supply electric generation supplier services as a Supplier to large commercial, industrial and governmental customers in the electric distribution company service territories of Duquesne Light Company, Metropolitan Edison Company, PECO Energy Company, PPL Electric Utilities Corporation, Pennsylvania Electric Company, and West Penn Power Company within the Commonwealth of Pennsylvania. On August 25, 2011, the license was amended to expand the service applicability to include residential and small commercial customers under a mixed meter scenario, pursuant to the Commission’s Secretarial Letter dated March 11, 2011 (Mixed Meter Letter) in Docket No. M-2009-2082042. On June 6, 2016, GDF SUEZ Energy Resources NA, Inc. filed an update notifying the Commission of a name change whereby GDF SUEZ Energy Resources NA, Inc. changed its name to ENGIE Resources Inc.

On June 30, 2016, ENGIE Resources Inc. was converted from a corporation into a limited liability company under the laws of the State of Delaware. The company’s new name is ENGIE Resources LLC (“ENGIE Resources”). Following the conversion into a LLC, on July 1, 2016, GDF SUEZ Energy North America, Inc. sold 100% of the membership interests in ENGIE Resources LLC to its affiliate ENGIE North America Inc., as part of an internal corporate reorganization. The transfer is effective July 1, 2016.

The changes noted herein will have no impact on the day-to-day operations of the company. ENGIE Resources' company information, including employee contacts, physical addresses and phone numbers, will remain the same.

For your reference, the following documents evidencing the name change noticed herein are provided in **Attachment 1**:

- (a) **A Certificate of Conversion filed in the State of Delaware converting ENGIE Resources Inc., a Delaware corporation, into ENGIE Resources LLC, a Delaware limited liability company (see Attachment 1);**
- (b) **A Certificate of Formation for ENGIE Resources LLC filed in the State of Delaware(see Attachment 1);**
- (c) **A Certificate of Good Standing was issued by the State of Delaware for ENGIE Resources LLC on July 6, 2016 (see Attachment 1); and**
- (d) **Transfer of Foreign Registration filed with the Pennsylvania Department of State Bureau of Corporations and Charitable Organizations on behalf of ENGIE Resources LLC (see Attachment 1).**

In addition, a hard copy of the confidential standby letter of credit to the Commission reflecting ENGIE Resources' new name is being filed separately with the Commission. ENGIE Resources respectfully requests that this confidential material be maintained by the Commission under confidential seal.

ENGIE Resources also hereby provides the following updates:

The new legal name of the company is ENGIE Resources LLC (*see Attachment 1*).

ENGIE Resources is now a limited liability company (*see Attachment 1*).

ENGIE Resources is providing an updated list of Officers & Directors in **Exhibit 1**. Biographies of the current officers overseeing the day-to-day operations of ENGIE Resources are provided in **Exhibit 2**.

ENGIE Resources is providing an updated chart depicting its current organizational structure in **Exhibit 3**.


ENGIE Resources is providing an updated list of its electric supplier licenses in other states in **Exhibit 4**.

Finally, ENGIE Resources hereby notifies the Commission that its predecessor received approval from the Federal Energy Regulatory Commission to be a Power Marketer in Docket No. ER16-583-001.

ENGIE Resources requests that the Commission update its records to reflect the new company name and the other updates provided herein. An electronic copy of this update has

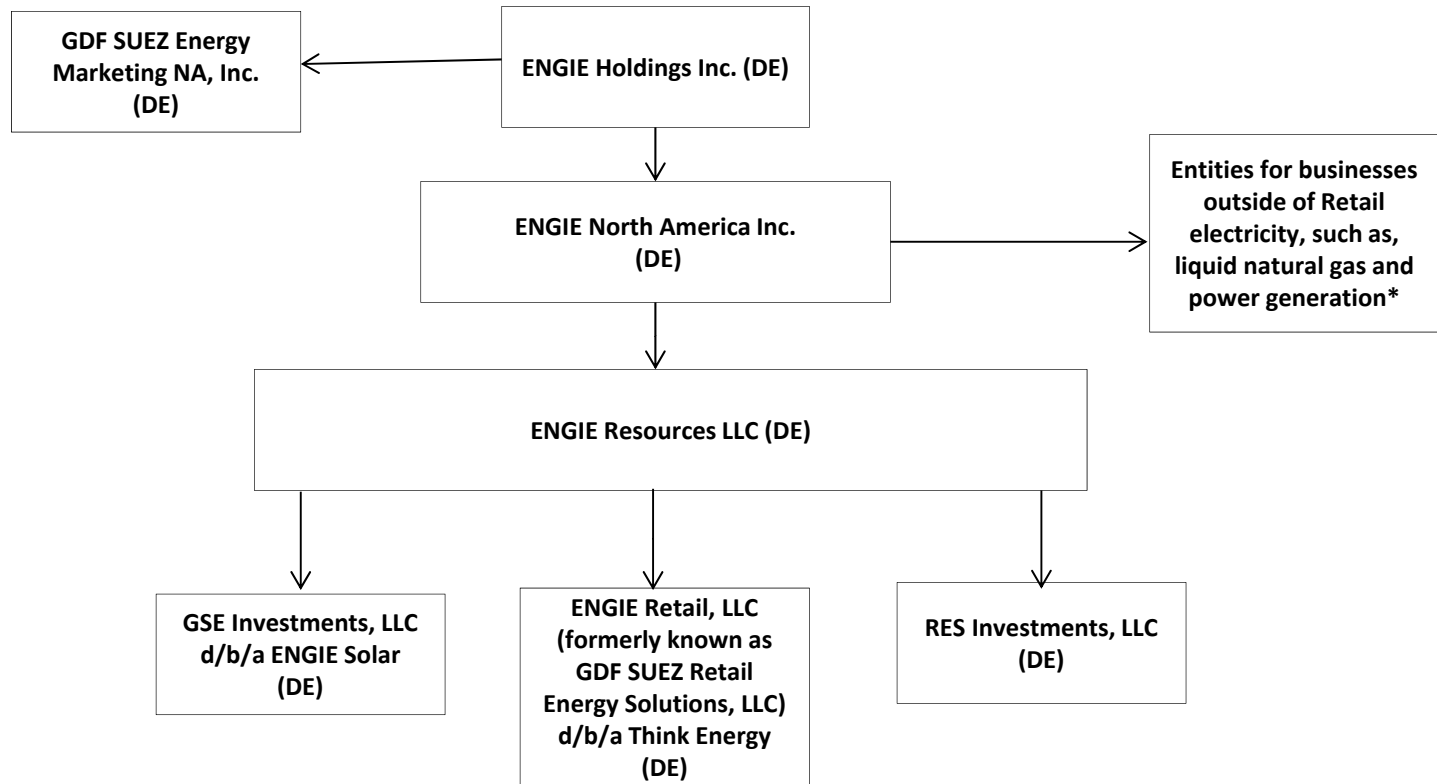


