To Whom It May Concern:


In accordance with the 20 PA. Code § 54.34, promulgated by the Public Service Commission of Pennsylvania, Respond Power LLC and Major Energy Services LLC, (the "Company"), a New York limited liability company and duly licensed electric generation supplier (A-2010-2163898) and natural gas supplier (A-2009-2118836) in the State of Pennsylvania, the Company hereby respectfully submits its license update:

On April 15, 2016, National Gas & Electric, LLC ("NGE"), an affiliate of Spark HoldCo, LLC, parent company of Spark Energy, LLC and Spark Energy Gas, LLC, as well as an affiliate of Spark Energy, Inc. (NYSE: SPKE), acquired 100% of the membership interests of the Company, thereby implementing a change of control of the ownership of the Company. Pursuant to a Membership Interest Purchase Agreement entered into May 3, 2016, NGE has agreed to sell all of its membership interests in the Company to Spark HoldCo, LLC. The Spark Closing took place on August 23, 2016.

The name, FEIN, and DUNS number of the Company shall all remain the same. The Company shall continue to serve its existing customers and to maintain its New York principal business address, New York in-state Resident Agent, in-state Customer Service Agent, and key operating personnel. Please find the Company's Officer's List, Representations of Corporate Officers and Certificate of Service attached hereto as Attachment A and made a part hereof.



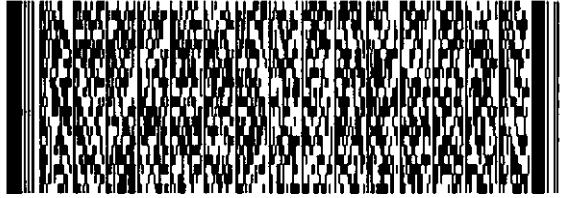

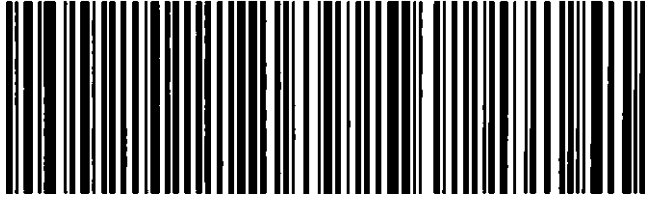
