As you are aware, this office represents the Applicant, Susquehanna Valley Taxi Service, Inc. in the above captioned matter.

On April 5, 2016, Applicant filed a transfer application seeking Commission approval for its acquisition of all of the taxicab rights previously granted by the Commission to Susquehanna Valley Limousine at Docket No. A-2015-2472707. On May 19, 2016, Pauls Cab Service, Inc. (Pauls) filed a letter protest to this application. On May 29, 2016, the undersigned filed Preliminary Objections to that protest. No Answer to those Preliminary Objections was ever filed.


By First Interim Order issued August 31, 2016, Your Honor held in abeyance any ruling on the Preliminary Objections until Pauls had an opportunity to obtain counsel. Your Honor further ordered Pauls to have an attorney enter his or her appearance on behalf of Pauls by September 16, 2016 or have its protest dismissed.
