MOTION FOR CONTINUANCE OF PPL ELECTRIC UTILITIES CORPORATION

PPL Electric Utilities Corporation (PPL Electric), by its attorney, hereby files a Motion for Continuance of Hearing in the above-captioned proceeding as follows:

1. By Hearing Notice dated August 1, 2016, a hearing in the above referenced matter was scheduled for September 6, 2016.
2. Upon Request for Continuance filed on behalf of Complainant, John McGee, the hearing was cancelled and rescheduled for October 5, 2016.
3. The Complainant's underlying Complaint concerns allegations of Foreign Load, and balance transfers related thereto.
4. The Foreign Load investigations were performed by Ronald Hoffman, PPL Customer Contact Representative.
5. On or about September 27, 2016, PPL Electric submitted its proposed exhibits, which include the notes of field investigations performed by Ronald Hoffman, PPL Electric Customer Contact Representative,

6. It has been the intent to PPL Electric to have Ronald Hoffman available at the hearing and to testify to his personal knowledge of the inspections and actions taken as a result of thereof.

7. Respondents, PPL Electric, received a request today, October 4, 2016, from Mr. Hoffman for a bereavement day on October 5, 2016 (the date of the hearing) to attend a family funeral.

8. As the instant action pertains to Foreign Load, which was investigated by Mr. Hoffman, Respondent, PPL Electric requests a continuance of the October 5, 2016 hearing so that Mr. Hoffman can attend the funeral and also testify at the time of hearing.

9. Counsel for Complainant has been advised of the request and has stated no objection to the request. However, Counsel for Complainant has advised of a pre-planned vacation November 28 through December 2, 2016 with a request that a hearing not be rescheduled during those dates.

10. Due to the nature of the reason for the request, namely a death, PPL Electric has been unable to provide five (5) days' notice of this request.

11. PPL Electric respectfully requests that the hearing in the above matter be continued and rescheduled so that Mr. Hoffman can testify at the hearing.

WHEREFORE, in view of the foregoing, PPL Electric respectfully requests that its Motion be Granted.


