

I am in receipt of your letter dated June 25, 1993, relative to the above-captioned action and the status of OTS-RE-23 and -24.

As I am sure you will agree, the Company responded, quite a long time ago, to OTS-RE-23 and I am unaware of any dissatisfaction on OTS' part relative to that interrogatory. If I am incorrect in this understanding, please contact me at your earliest convenience.

With respect to OTS-RE-24, the adjustments to book figures to annualize and normalize expenses was provided to the parties on May 19, 1993 and, thus, has been available to OTS since that time. Both Mr. Cawley and myself have so stated to OTS on several occasions. The information originally provided by the Company which referred to CTCO Statements 3 and 3-A and CTCO Exhibits DPC-6 and -8 were responsive on an intrastate basis, which is the basis of the Company's case in this proceeding. We understand that the Staff would like to design a "total company" rate case and, although CTCO disagrees with this methodology, has worked with the Staff to provide it with the figures and data it needs to calculate a result in this fashion.

Specifically, on Monday, June 21, 1993, CTCO representatives met in informal discovery with OTS and discussed the outstanding data required by the Staff. All information requested by the OTS in that meeting was served upon the parties on Friday, June 25, 1993. When Staff again sought additional information, this time on June 25, 1993 in the afternoon, I attempted to obtain a list of information which was needed by the Staff and, since there appeared to be some confusion, suggested that Messrs. Korn and McGuire call Don Cawley of CTCO directly. It is my understanding that, in the afternoon, they did discuss matters further and additional information was requested, which

Mr. Cawley then provided on Monday, June 28, 1993 as they had requested. Again, today, June 29, 1993, the Staff requested further additional information which has been sent to Trial Staff. I presume that the conference call with the Judge was cancelled, because OTS found this information to be satisfactory.

Since you copied Judge Kashi on your letter, I felt the necessity to respond in writing, although I believe the matter to be resolved. I was somewhat dismayed by the last statement in your letter, which seemed to at least infer that CTCO had not been willing to discuss matters directly with the OTS technical staff, whereas in point of fact we had met with Mr. McGuire on Monday, June 21, 1993 and, as of Friday afternoon, June 25, 1993 (but prior to the sending of your letter of that same date), Mr. Korn had already spoken with Mr. Cawley, with assurances that if additional information were needed, that such would be provided.

Thank you for your attention to this matter.


