

1. REQUEST

Reference Application, Section 7.a, Bonding - Applicant filed a bond containing outdated language, as well as containing two instances of using a © instead of using (c). Please file an updated bond correcting the typos, and using the template language from the below link. Applicant can elect to mark submitted information as confidential.

ANSWER 1:

Aggressive Energy is in receipt of the updated bond language and is currently working with the Bond Company to correct the typos in the submitted bond. Aggressive Energy respectfully requests additional time to work with the bond company and will provide the requested corrected language and fully executed bond ASAP. As a reminder, a valid \$250,000 fully executed bond was properly submitted with the original application before the updated language change over as acknowledged in the Data Request ("DR"). While Aggressive Energy ("AE") is working on the updated bond as fast as possible, and will fully comply with any/all requested information, we hope that the existing bond will allow the application to continue to move forward and not pause and/or hold up the approval process. It is well founded in PA case law that a mere typo in an otherwise legal and fully executed binding document, contract, bond, letter of credit, and/or guarantee does not invalidate the document and a valid bond with a minor typo can be executed upon. That being said, the updated fully executed Bond as requested in the DR will be provided ASAP.

2. REQUEST:

Reference Application, Section 7.c, Supplier Funding Method - Applicant indicated in this section a reference to Appendix D and O as attached to the application. Appendix D was not included, please provide this Appendix. Also, Applicant did not provide any credit agreements or other credit facilities in its application package. If applicant maintains a credit agreement or other credit facility, applicant must submit them in their entirety. Applicant can elect to mark submitted information as confidential.

ANSWER 2:

AE is familiar with Section 7.c. which was answered in the originally submitted application received on June 15th. Additionally, AE hopes that both Appendix D and O were received as they were sent and even referenced as if they were received in other sections of the DR. Appendix D is the \$250,000 Bond with is fully executed. Both the original Bond and a copy of the Bond were submitted with the application. Additionally, as noted in ANSWER 1, the updated Bond with corrected typo is being worked on with the bond company and will be provided ASAP.

Additionally, Appendix O was also submitted with the original application and as required, was submitted as a Confidential documents with the proper motion which is still applicable. Since Appendix O does contain highly confidential information and as

noted in the DR the information can be marked and submitted as confidential which AE is electing to do again in response to the DR. It should be noted that an updated response is being submitted further detailing AE's credit and credit facilities.

3. REQUEST:

Reference Application, Section 7.f, Taxation - Applicant failed to provide a Sales Tax License number on its Tax Certification Statement. Please provide a fully completed Tax Certification Statement. Applicant can elect to mark submitted information as Confidential.

ANSWER 3:

Sales tax license number provided as requested and marked as confidential.

4. REQUEST:

Reference Application, Section 8.a, Technical Fitness - Applicant claims it uses vendors with areas of expertise in Electric Scheduling, Electric Nominations, etc. Please provide the names of these vendors, along with information related to their areas of expertise. Applicant can elect to mark submitted information as confidential.

ANSWER 4:

Please see attached confidential information detailing vendors as requested and which can be added to the existing Appendix P.

5. REQUEST

Reference Application, Section 10.a, PJM Load Serving Entity Requirement -Applicant indicated in it's application that is a Load Serving Entity (LSE) in PJM. However, the documentation submitted by applicant failed to demonstrate that it was registered as an LSE with PJM. Please submit evidence of PJM LSE status. Applicant can elect to mark submitted information as confidential.

ANSWER 5:

Please see attached letter from PJM indicating AE is an approved LSE in good standing.

6. Request:

Reference application, Section 12, Newspaper Publications - Applicant failed to submit Notarized Proofs of Publication for the Pittsburgh Post-Gazette and the Williamsport Sun-Gazette with its application package. Please provide these Notarized Proofs of Publication.

ANSWER 6:

The original notarized proofs of publication for both the Pittsburgh Post-Gazette and the Williamsport Sun Gazette were provided and submitted to the Secretary's Office as required. Between the July 11th filing and the July 19th filing all required newspaper originals should be part of AE's Application and received by the Secretary's Office. That being said AE has reached out to both newspapers in an attempt to obtain originals to re-submit to the Secretary's Office. Additionally, a copy of the Williamsport

Sun-Gazette is provided here. While Aggressive Energy ("AE") is working on the updated bond as fast as possible, we hope that the existing bond will allow the application to continue to move forward and not pause and/or hold up the approval process. 


