Please accept this notification of Joint Complainants of compliance with paragraph 26 of the Joint Petition for Approval of Settlement, page 30 of the Initial Decision dated August 21, 2015, and the final Order dated December 3, 2015 in the above-captioned proceeding. On October 13, 2016, the Commonwealth of Pennsylvania, Office of Attorney General, through the Bureau of Consumer Protection and the Acting Consumer Advocate, Tanya J. McCloskey provided the September Report of the Administrator of the Refund Pool to HIKO Energy, LLC, the Pennsylvania Public Utility Commission's Bureau of Consumer Services, and Administrative Law Judges Elizabeth Barnes and Joel Cheskis in the format and medium requested by each.

Specifically, 8,070 checks were issued on May 13, 2016, representing checks to all eligible customers. Through September 30, 2016, of those checks issued, 5,849 refund checks totaling \$1,429,171.78 were cashed and paid; 990 refund checks totaling \$294,716.40 were returned undeliverable; and 1,231 refund checks totaling \$301,495.45 were delivered and still uncashed.
