The following are responses to a Data Request submitted to NG&E by letter dated September 23, 2016 Pennsylvania PUCO concerning the above-referenced Docket Numbers:

1. Bargain is still active in the State of Pennsylvania but plans to cease its operations in that State on November 1, 2016.
2. Gross Revenues for Bargain being assigned to NG&E for the past two years by quarter for the sales of electricity to customers in Pennsylvania are reflected on the attached Exhibit "A".
3. Bargain has served the Pennsylvania Public Utility Commission's Bureau of Investigation & Enforcement with a copy of its Notification of Transfer of Customers filing. A Certificate of Service is attached hereto as Exhibit "B".
4. Bargain will NOT continue to have a business presence in Pennsylvania after License cancellation. Bargain has NOT provided formal notification to the Pennsylvania Department of Revenue that intends to go out of existence/withdraw from Pennsylvania for tax purposes but intends to do so before the end of October 2016.
5. 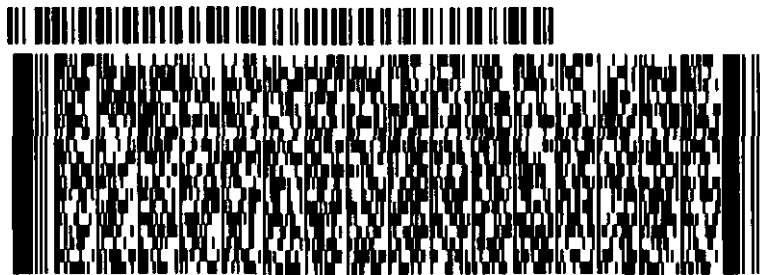
