Dear Sir,

I am writing in response to the complaint, filed against me by your agency, which I received today. The file number is A-00118148C0201.

With all due respect to Mr. Hoffman and the Commission, I did inform the Commission during the week of 15 August of 2002, that I would no longer be operating as a Courier in the State Of Pennsylvania, or in any other state, and that I had not done so since 15 July 2002. These statements are true and verifiable. The companies for which I provided service were UPS Logistics/Sonicair, Quality Service Courier and Sims On Time Service, all of whom will attest to the fact that I have not provide service for them since the time indicated above.

On 15 August 2002, I began working in the Access Control Center at the Three Mile Island Nuclear Power Station in Middletown PA and ceased to operate as a courier one month prior to that date. My supervisor is Gregory DeHoff and he is able to verify my date of employment. He can be reached at 717-948-8375.

Both of the insurance companies who have provided insurance on my vehicle can also verify the dates that the insurance was switched from commercial vehicle insurance with Progressive to personal vehicle insurance with Allstate in August of 2002. I could not have done this and continued to make a living as a courier, as my primary source of income was UPS Logistics and they require verification of commercial vehicle insurance from all drivers who provide service for them.

My tax records for this year will also reflect that I did not operate as a courier after 15 July 2002.
