A certificate of public convenience will be issued UPON THE FILING OF PERMANENT PROOF OF INSURANCE and compliance with any other provision of this letter:

- a. Form E, as evidence of bodily injury and property damage liability insurance.

FAILURE TO FILE THE ABOVE REQUIRED EVIDENCE OF INSURANCE AND/OR COMPLY WITH ANY OTHER PROVISION OF THIS LETTER WITHIN SIXTY (60) DAYS OF THE DATE OF THIS LETTER WILL RESULT IN THE DISMISSAL OF THE APPLICATION AND REQUIRE THE FILING OF A NEW APPLICATION AND FILING FEE.


You may operate pending the filing of permanent proof of insurance (Temporary proof of insurance is only good for 60 days from the date of this letter). You may operate the following authority:

To transport, as a motor common carrier, property, excluding household goods in use, between points in Pennsylvania.

Upon the filing of permanent proof of insurance, and upon compliance with any other provision of this letter, a certificate of public convenience will be issued authorizing the service cited above.

If you have not previously submitted a copy of current satisfactory safety rating from the U.S. Department of Transportation or another state with safety regulations comparable to Pennsylvania, you must demonstrate safety fitness by completing a Safety Fitness Review which will be scheduled by a PUC enforcement officer within 180 days of the date your certificate of public convenience is issued/entered. **Failure to submit to the Safety Fitness Review will result in dismissal of your application.**
