PETITION FOR SECURITY LEVEL REDUCTION

Before the Pennsylvania Public Utility Commission (the "Commission"), pursuant to 52 Pa.Code Section 54.40(d) American Power & Gas of Pennsylvania ("AP&G"), LLC hereby files this Petition for Security Level Reduction of our bond security level from 10% to 5%. In support of this petition for Security Level Reduction, AP&G states the following:

- In February of 2013 AP&G submitted our application to become a Supplier of Electricity. This application included the initial letter of credit in the amount of \$250,000. The application was approved on July 16th, 2013.
- 2. On September 24, 2015 we received a letter that our license security bond needed to be increased to **security** based on our gross receipts. Our letter of credit was amended with the Commission.
- 3. AP&G standardly complies with the PUC reporting and security requirements.
- 4. At Exhibit A is Proof of service of this petition on the statutory advocates and affected EDCs.
- 5. At Exhibit B is copies of our gross receipts for the most recent four quarters. (Confidential)
- 6. At Exhibit C is our Tax Letter of Good Standing.

For these reasons, AP&G respectfully submits that the Commission grant its Petition for Security Level Reduction from 10% to 5% of our most recent 12 months of gross receipts or \$250,000 which is higher.


