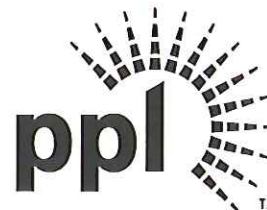

RIGHT OF WAY GRANT FOR TREE WORK
(Corporation)

KNOW ALL MEN BY THESE PRESENTS, That Bethlehem Parking Authority, a parking authority of Pennsylvania hereinafter called "GRANTOR," intending to be legally bound, does hereby for itself, its successors and assigns, grant unto PPL Electric Utilities Corporation, hereinafter called "COMPANY" its successors and assigns, the right, privilege and authority to cut down any and all trees within twenty-five (25) feet each side of centerline of the electric/communication line and the right to trim any and all trees within twenty-five (25) feet each side of centerline of the electric line and to remove brush along said lines which in the judgment of the said Company menace the said lines; on property identified as County Tax Parcel No. P6SE2A 29 31 0204E which the undersigned owns or has any interest located along Atlantic Street situate in the City of Bethlehem, County of Northampton, Commonwealth of Pennsylvania.

A copy of this agreement and an acceptance hereof by PPL shall be filed by PPL with the Pennsylvania Public Utility Commission, and this agreement shall thereafter become effective in accordance with the provisions of the Public Utility Law.

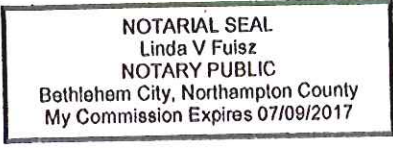

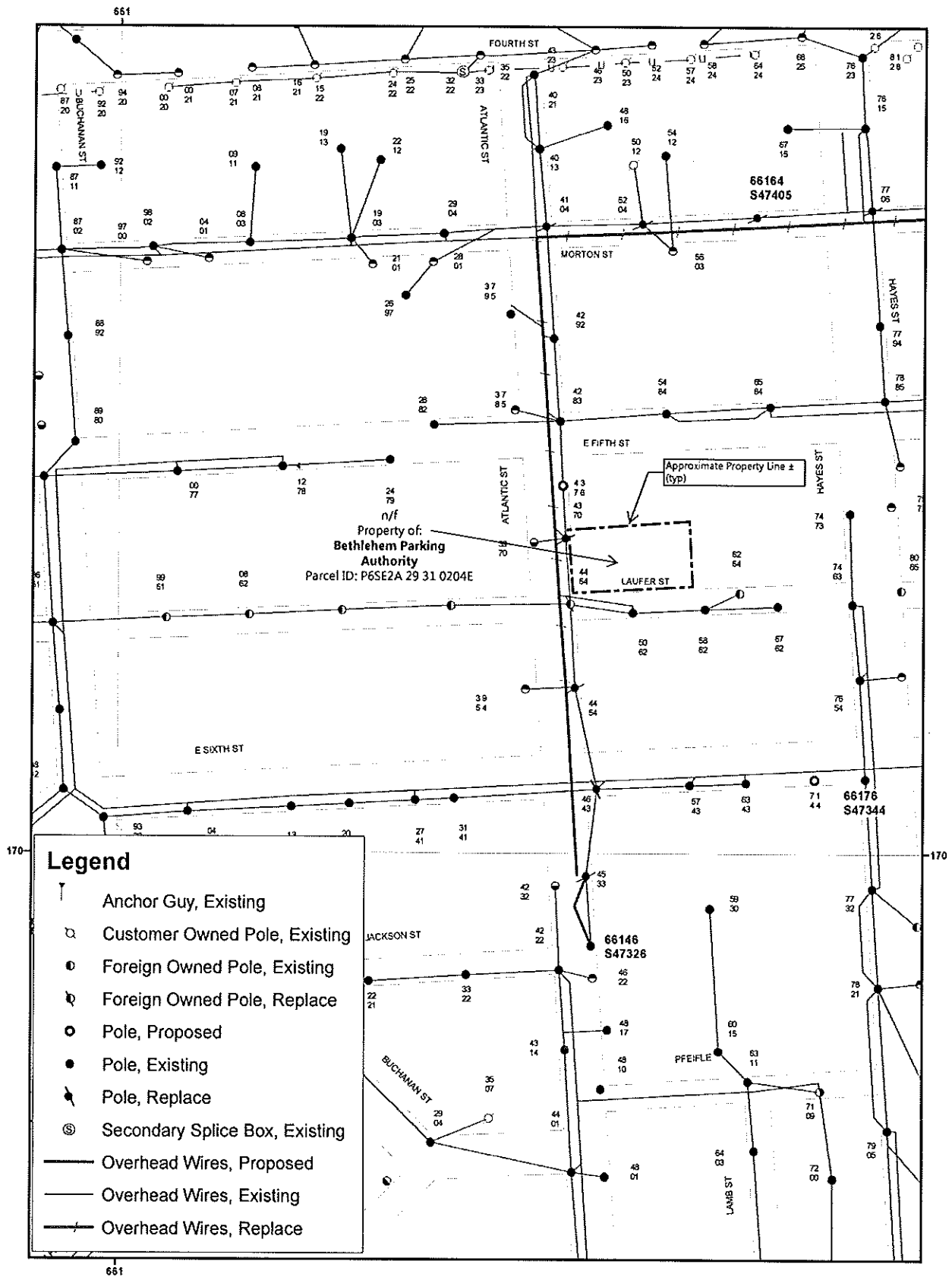
