RESTRICTIVE AMENDMENT

Comes now, Trinity Luxury Transport, LLC, the Applicant in the above captioned matter (hereinafter called "Applicant"), by and through its partner, Shari L. O'Connell; and Protestant J & J Leasing & Rentals, Inc. (hereinafter called "J&J" or "Protestant") by and through its attorney, Kenneth A. Olsen, Esq., and file this Restrictive Amendment as follows:

1. The above captioned application is hereby amended to read as follows:

For the right to begin to transport, as a common carrier by motor vehicle, persons in limousine service, between points in Pennsylvania, excluding service that is under the jurisdiction of the Philadelphia Parking Authority.

Provided that no right, power, or privilege is granted to provide limousine service from or between points in the Counties of Lehigh or Northampton.

2. Applicant agrees to the above Restrictive Amendment and affirmatively states that it presently does not have the interest to originate from or transport between points in the Counties of Lehigh and Northampton, as set forth above in the Restrictive Amendment.

3. As stated in its October 13, 2016 protest, Protestant currently provides limousine services of persons from, to, and within Lehigh and Northampton Counties pursuant to its existing operating authorities.

4. Based upon the Restrictive Amendment set forth in Paragraph 1 above, and conditioned upon its acceptance by the Commission and its incorporation into any subsequent final

order issued by the Commission, Protestant agrees to withdraw its protest to the application as amended. However, Protestant desires to remain a party of record to receive copies of any decision or order issued by the Commission herein.

5. If the Restrictive Amendment is not accepted by the Commission, the parties agree that further hearings shall be held to permit Applicant and Protestants to present evidence in support of or in opposition to the Application.

WHEREFORE, the parties, intending to be bound have hereunto set their hands and seal as of this day of *November 11*, 2016.


