Blair Cab Inc. t/a Yellow Cab & Transfer Company (Respondent) has paid, in full, its outstanding assessment balance for the July 1, 2015 to June 30, 2016 Fiscal Year (2015-2016 Fiscal Year) and the civil penalty in order to resolve the above-docketed complaint without litigation.

On July 7, 2016, the Commission received a check in the amount of \$1,131, which constitutes payment of Respondent's outstanding assessment balance for the 2015-2016 Fiscal Year, and on November 7, 2016, the Commission received a check in the amount of \$1,170, which constitutes payment of the civil penalty for Respondent's failure to timely pay the Commission's assessment and file an assessment report demonstrating its gross intrastate revenues earned during the 2014 calendar year.

Given that the outstanding assessment and civil penalty have been satisfied in the above-referenced matter, I&E hereby withdraws the motion for default judgment filed on August 29, 2016 pursuant to 52 Pa. Code § 5.94.


